FOREWORD



Dear Colleagues, Honorable Members of Parliament,

I am pleased to present the Annual Report of Parliament for the period 2013-2014.

In the first half of 2013 a change of the Executive branch of government took place effectively June 14, 2013 when a new coalition government was sworn in.

As a consequence of the new composition of Government a majority in Parliament elected a new President of Parliament on June 24, 2013. This Parliamentary year recorded several highlights, including:

- The historic visit to Parliament of His Majesty King Willem Alexander and Her Majesty Queen Maxima;
- The hosting of three Committee meetings of the Parliament of Latin America and the Caribbean (Parlatino);
- The establishment of the President of Parliament award;
- The hosting of Tripartite meeting.

Additionally, the Rules of Order of Parliament were amended and approved on April 14, 2014 and went into effect on June 1, 2014.

In an on- going effort to provide Members of Parliament and personnel of the Secretariat with necessary information to enhance performance, a Master Class on Public Finances organized by the General Audit Chamber on October 3, 2013, as well as a training funded by USONA and given by Hanze Legal Consultancy on August 7, 13, 14 and 15, 2014 concerning the functioning of Parliament, the Constitution and the Kingdom Charter were held.

It is our objective to provide these trainings to the new Members of Parliament and support staff as soon as the 2nd Parliament for Country Sint Maarten is sworn in. We will continue with inviting all schools and the public to visit the House of Parliament, in our effort to familiarize our youth and citizens with this new institution of Governance.

Sint Maarten's Parliament would not be able to achieve its objectives without true commitment and dedication of a trained and motivated staff. We look forward to more creativity and consistency in the execution of our tasks.

I sincerely hope that the next Parliamentary year will be even more productive than the year before. As we move forward with dedication and a sense of purpose to work on behalf of those to whom we are elected and appointed to SERVE , The People of Sint Maarten.

INTRODUCTION PARLIAMENT OF SINT MAARTEN

TASKS AND COMMITTEES OF PARLIAMENT

The Parliament of Sint Maarten is the highest legislative body of the country and according to article 44 of the Constitution it represents the entire population of Sint Maarten. The Parliament currently consists of 15 members who are elected for a four-year period.

According to article 46 of the Constitution the Parliamentary year commences with a public session on the second Tuesday of September. During this meeting, the Governor delivers a speech laying out the policies of the government for the coming year.

Parliament elects a President and Vice-Presidents from their own number. Together they form the Presidium. If the President is not available, the Presidency shall be taken over by one of the Vice-Presidents.

The main tasks of the President are:

- supervising the activities of Parliament and the Presidium;
- ensuring that the Rules of Order are adhered to;
- maintaining order during and the adjourning of deliberations
- executing decisions taken by Parliament and;
- representing Parliament;

The Parliament has Rules of Order that regulate amongst others the procedure of meetings. Meetings of Parliament are public unless it is considered necessary, or it is requested by four members, to hold the meeting behind closed doors. According to article 21 of the Rules of Order. Parliament consists of various permanent and special committees. Currently there are 11 committees:

- Central Committee;

- Committee of Petitions;
- Committee of Housing, Spatial Planning, Environment and Infrastructure;
- Committee of Justice;
- Committee of Finance;
- Committee of Tourism, Economic Affairs, Transport and Telecommunication;
- Committee of Education, Culture, Youth and Sports Affairs;
- Committee of Health Care, Social Development and Labor;
- Committee of Kingdom Affairs and Interparliamentary Relations;
- Committee of Country's Expenditures;
- Ad Hoc Committee for the Preparation of the Construction of the New Building for Parliament.

The Seniorencollegium, comprising of the President and faction leaders of the parties represented in Parliament according to article 12 of the Rules of Order, plays a key role in the functioning of Parliament. In this setting often political issues are discussed in order to determine each faction's standpoint before they go to a public meeting.

The powers of Parliament are:

- co-legislator (article 82 of the Constitution);
- the right of initiative (article 85 of the Constitution);
- the right of amendment (article 86 of the Constitution);
- exercise control over government's policies;
- the right to ask questions (article 62 of the Constitution);
- the right of interpellation (article 63 of the Constitution);
- the right of inquiry (article 64 of the Constitution);
- the right to approve and amend the budget (article 100 of the Constitution);

COMPOSITION OF PARLIAMENT

At present the Parliament of Sint Maarten consists of seven factions: the faction of the United Peoples Party (5), the faction of the National Alliance (4), the faction of the Democratic Party (2), the faction of Independent Member of Parliament Patrick G. Illidge (1), the faction of Independent Member of Parliament Frans G. Richardson (1), the faction of Independent Member of Parliament Romain J. Laville (1) and the faction of Independent Member of Parliament Lloyd J. Richardson (1).

As of June 24, 2013 the Hon. drs. Gracita R. Arrindell is the President of Parliament. Member of Parliament the Hon. R.J. Laville is the 1st Vice-President and Member of Parliament the Hon. P.L. de Weever is the 2nd Vice-President of Parliament.

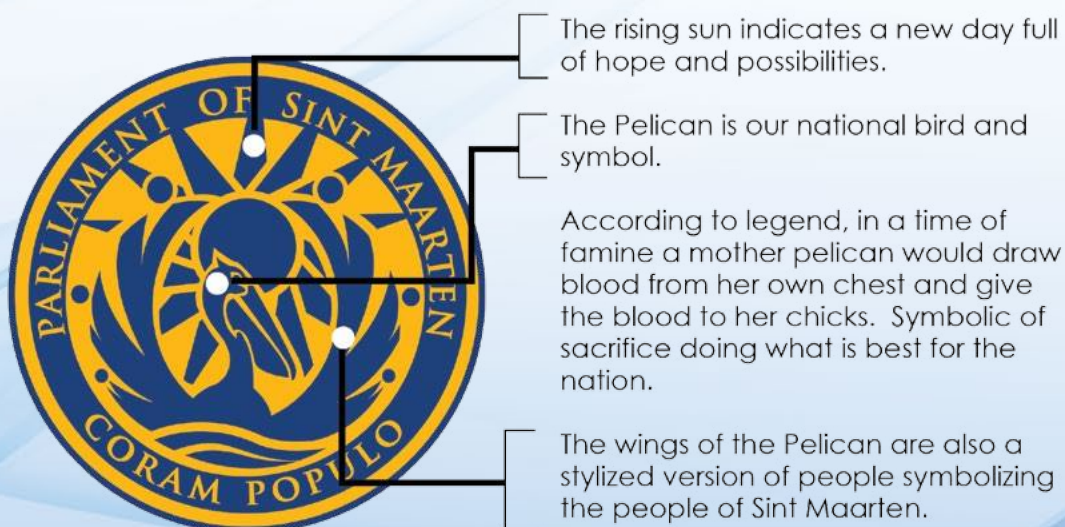
SUPPORT OF PARLIAMENT

The Parliament has a secretariat at its disposal. The core tasks of the secretariat is to give administrative support, procedural and legal advice to the President of Parliament, the Members of Parliament and Parliament as a whole. One of the most crucial tasks of the secretariat is the preparation of the meetings. The public Parliament meetings are carried live on St. Maarten Cable TV--Channel 120, via Pearl Radio FM 98.1, via the Internet www.pearlfradio.com and also via www.sxmparliament.org.

To achieve these principal tasks the secretariat is headed by the Secretary General. As of May 10, 2014 the Parliament of Sint Maarten has a new Secretary General, Ms. Nancy R. Joubert, LL.M. and two acting Secretary Generals, Mr. Van Dyke A. Bell, and Mrs. Ann A. Groen-Gumbs, LL.M. Furthermore the Secretary General is assisted by an Advisor, Mr. lic. Jozef D. Semeleer. The administrative staff in the secretariat totals 8.

It should also be noted that the factions in Parliament are supported by their own faction staff. At present there are 19 faction staff members employed with the different factions.

FINANCIAL OVERVIEW

CASH FLOW STATEMENT

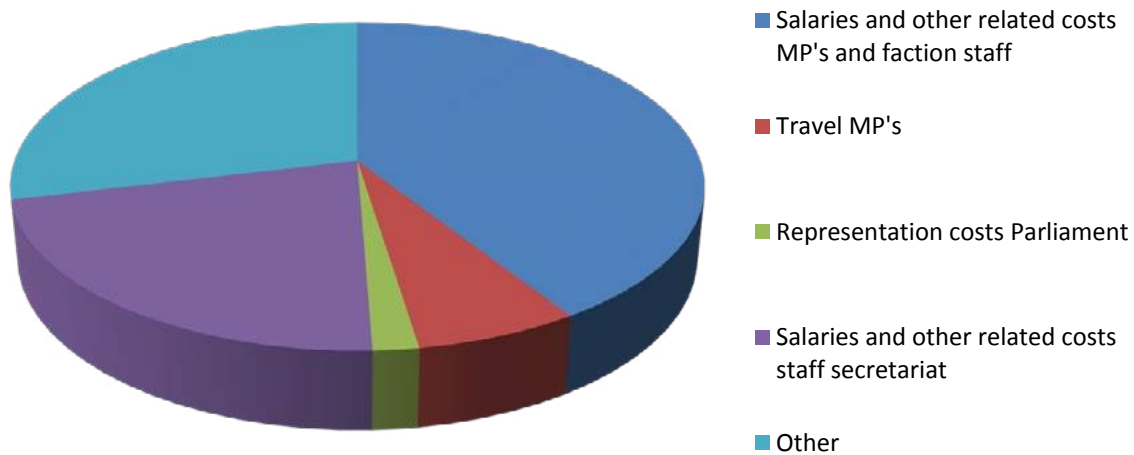
For the budget year 2013 Parliament had a total amount of Nafl. 10.139.595 at its disposal, which included both the costs of Parliament (budget post 2020) as well as the costs of the secretariat (budget post 2030). Parliament's actual expenses totaled Nafl. 10.708.074 in the budget year 2013, 568.479 guilders more than budgeted. It should be noted that this overdraft is caused by expenses that have been booked on budget posts for which Parliament did not have any amounts budgeted.

These expenses included the salaries and other related costs of the Members of Parliament and their faction staff (40.92%), costs of travel for the Members of Parliament (6.63%), representation costs (1.85%), salaries and other related costs of the staff of the secretariat (21.84%) and other expenses (28.76%). The category "other" included amongst others gas for vehicles, office, kitchen and cleaning supplies, obligations deriving from contracts with third parties, books and subscriptions, uniforms for the staff of the secretariat, legal and other advice, courses and training, membership and other dues etc.

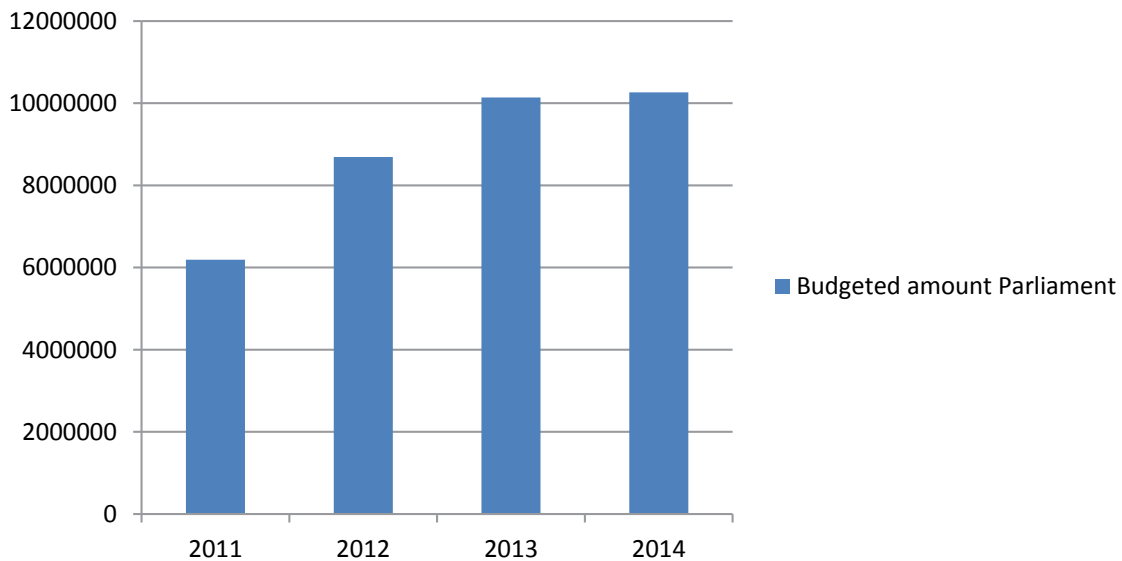
In accordance with article 35 sub a of the Compatibility ordinance and article 17, paragraph 1 of the Rules of Order of Parliament the draft budget of Parliament for the budget year 2014 was submitted to the Minister of Finance on April 25, 2013 (UV/100/2012-2013). The draft budget of Parliament was deliberated and accepted in the Presidium on April 22, 2013 and in the Seniorenconvent on April 23, 2013.

The Ordinance establishing the budget for Country Sint Maarten for the budget year 2014 was adopted on January 16, 2014. For the budget year 2014 a budgeted amount of Nafl. 10.265.437 was approved for Parliament. The increase of approximately Nafl. 125.842 compared to budget year 2013 is due to the fact that 2014 is an election year. With this in mind, provisions were made in case one or more Members are not re-elected. In that case the Member has a right to a benefit in accordance with article 3 and further of the National ordinance regulating benefits and pensions for political authorities and pensions for surviving dependents for a maximum of 24 months, starting on October 10, 2014.

PARLIAMENTARY YEAR IN REVIEW

The following provides an overview of the work done by Parliament during the Parliamentary Year 2013 - 2014



SEPTEMBER 10, 2013

A Solemn Public meeting was held on this day to mark the opening of Parliamentary Year 2013-2014. His Excellency the Governor of Sint Maarten, drs. E.B. Holiday, delivered a speech on the policies of government for the new Parliamentary Year. This Solemn Public meeting was followed by a military parade as is customary and a reception hosted by the President of Parliament, the Hon. drs. Gracita R. Arrindell, at the Sundial School. During the reception the first President of Parliament Award was presented to Mr. W. Laurence, by the President of Parliament, for being a great example to the youth and for having contributed positively to the community.

SEPTEMBER 11, 2013

On Wednesday, September

11, 2013, in Public meeting no. 1, the credentials of Mr. William V. Marlin were approved. Furthermore the advices on the installation and constellation of the permanent and special committees of Parliament and the committees of Parliament were approved.

SEPTEMBER 12, 2013

On this day Parliament adopted the following law:

- *Landsverordening tot wijziging van het goedgekeurde ontwerp van landsverordening begroting 2013 (Zittingsjaar 2012-2013-035) (9 votes for and 6 against)*

National Ordinance amending the approved National Ordinance stipulating the Budget for the year 2013

OCTOBER 3, 2014

The General Audit Chamber organized a Masterclass on "Public Finance: Roles and Responsibilities" for the Members of Parliament at the Divi Little Bay Resort. A presentation was given on the financial cycle of government, the annual accounts and

the role of Parliament in the financial cycle. The Masterclass was followed by a lunch on site.

The intention of the training was to increase the knowledge of the Members of Parliament on public finances.

OCTOBER 7, 2013

A Public meeting was held on October 7, 2013 in which the credentials of Mr. Theodore E. Heyliger were approved. In the same Public meeting the following laws were adopted:

National Ordinance amending the Civil Procedure Code regarding civil claims and Bankruptcy Decree of 1931 with additions to the new Civil Code

OCTOBER 8, 2013

Representatives of the Central Bank of Curaçao and Sint Maarten provided the Central Committee with information on the license fee being charged by commercial banks to individual account holders on this day. In the power point presentation given to Parliament the legal basis, the implementation, the license fee revenues and the issues with the license fee on Sint Maarten were mentioned.



OCTOBER 10, 2013

On October 10, 2013 Parliament commemorated in a solemn Public meeting, the third anniversary of the attainment of Sint Maarten's new constitutional status within the Kingdom of the Netherlands. On this occasion Parliament hosted several guest speakers such as representatives of Teen Times Mr. Sakir De Castro and Ms. Rochana Richardson as well as Mr. Jan Hendrik Albert (Henny) Eman, the first Prime Minister of Aruba that led his country through many challenges. The ceremony commenced with a rendition of the Sint Maarten song by Ms. Mischulaikah Richardson and Mr. Benjamin Bell. The faction leaders present as well as the Prime Minister, the Hon. Sarah A. Wescot-Williams addressed the meeting.



OCTOBER 17-19, 2013

A delegation of the Parliament of Sint Maarten, headed by the President of Parliament the Hon. drs. Gracita R. Arrindell and furthermore comprising of Member of Parliament the Hon. Patrick G. Illidge, Member of Parliament the Hon George C. Pantophlet, Member of Parliament the Hon Romain J. Laville, Member of Parliament the Hon Petrus L. de Weever and Member of Parliament the Hon Silvia V. Meyers-Olivacce travelled to Panama to attend respectively the Board of Directors meeting (Junta Directiva), the Solemn Session for the inauguration of the headquarters of Parlatino and the annual General Ordinary Assembly of Parlatino. Topics that concern all member countries of Parlatino were discussed during the General Ordinary Assembly such as the economic reform in the framework of the global crisis, the Nagoya Protocol on access to genetic resources and the fair and equitable sharing of

benefits arising from their utilization to the convention on biological diversity and international arbitrage in Latin America.

OCTOBER 28, 2013

In Central Committee no. 9 the following agenda point was discussed:

- *Discussion with the member of the Settlement Committee, Mr. Jean James to provide Parliament with an update on the activities of said committee.*

Mr. Jean James provided Parliament with an update of the work of the Settlement Committee so far as well as the work still ahead.

NOVEMBER 4, 2013

On this date a Public meeting was held with the following agenda point:

- *The decision of Government to establish a committee to conduct an investigation on integrity within the Government of Sint Maarten and to invite the Minister of General Affairs to be present.*

The Prime Minister and Minister of General Affairs was present to answer questions of Members of Parliament concerning this agenda point.

NOVEMBER 13, 2013

On this day His Majesty King Willem Alexander and Her Majesty Queen Maxima graced the Parliament of Sint Maarten with their presence. During this brief visit the Members of Parliaments had the opportunity to exchange a few words with His Majesty the King and Her Majesty the Queen in the Legislative Hall of Parliament. After this



brief meet and greet gifts were presented to Her Majesty the Queen by Ms. Rheanne Arrindell for the 3 princesses on behalf of the Parliament of Sint Maarten, followed by the departure of the Royal couple.

This visit was part of a 2 day visit to the island of Sint Maarten of His Majesty the King and Her Majesty the Queen. During their visit

the Royal couple also visited the Council of Ministers, the Milton Peters College and the Raoul Illidge Sports Complex.

DECEMBER 3, 2013

A Public meeting with the following agenda point was held on this date:

- *Minimum wage on Sint Maarten*

During this meeting a motion was passed unanimously requesting the Minister of Health Care, Social Development and Labor to carry out within 60 days a survey to determine the level of a “living wage” for Sint Maarten and to report back to Parliament.

DECEMBER 3, 2013

On this day the President of Parliament drs. Gracita R. Arrindell attended the Joint Assembly of the Dutch Houses of Parliament as a special delegate concerning the Draft Kingdom law appointment of a regent in case of succession by the King who has not reached the age of eighteen years (00010/R2011).

DECEMBER 12, 2013

On this day in Public meeting no. 6:

- *The discussion surrounding the 100 million guilder write*

was discussed in the presence of the Minister of Finance.

JANUARY 6-10, 2014

The Interparliamentary Kingdom Consultation (IPKO) was held in Curaçao during the week of January 6-10, 2014.

A Presidium meeting was held on Monday, January 6, 2014 at the Parliament building of Curaçao. Present were the Presidents of Parliament of Aruba, Curaçao and Sint Maarten, the Presidents of the Committee for Kingdom Affairs of Aruba, Curaçao and Sint Maarten, the Presidents of the Committee of Kingdom Affairs of the Dutch First and Second Chamber and the Secretaries General.

The IPKO was officially opened by the President of Parliament of Curaçao, Mr. M. Franco on January 7, 2014 at the Renaissance Curaçao Resort & Casino. His welcome speech was followed by opening speeches of the delegation leaders of the other countries. Thereafter the deliberations on

the issues of concern started which included feedback on several previously discussed subjects such as energy, education, youths and health.

On Tuesday after lunch the four parliamentary delegations continued their deliberations with respect to integrity in the public administration within the Kingdom.

On Wednesday and Thursday the deliberations proceeded about racism and intolerance within the Kingdom and economic opportunities for the Kingdom. The Members of Parliament also visited the Coast Guard, Marines and the University of Curaçao. On Friday morning the last day of the IPKO, the decision list was signed and a joint press conference took place that included the four delegations. The President of Parliament of Curaçao, Mr. M. Franco, hosted a dinner that evening for the visiting delegations.

The Sint Maarten delegation was headed by President of Parliament, the Hon. drs. Gracita R. Arrindell. Member of Parliament

the Hon. Roy R. Marlin, president of the Permanent Parliamentary Committee for Kingdom Affairs and Inter-parliamentary Relations, Member of Parliament the Hon. William V. Marlin, Vice president, Member of Parliament the Hon. Patrick G. Illidge, Member of Parliament the Hon. Frans G. Richardson, Member of Parliament the Hon. Romain J. Laville and Member of Parliament the Hon. Johan E. Leonard were all part of the delegation. The delegation also included Member of Parliament the Hon. Dr. Lloyd J. Richardson, Secretary General Jozef D. Semeleer and Advisor Ralph Richardson.

JANUARY 15, 2014

The following law was adopted:

- *Landsverordening tot vaststelling van de Begroting van het Land Sint Maarten voor het dienstjaar 2014 (Zittingsjaar 2013-2014-036) (11 votes for and 4 against)*

National Ordinance stipulating the Budget of Country Sint Maarten for the year 2014 (National Ordinance Budget 2014)

In this meeting 4 motions were also adopted concerning the operational loss subsidy

that was paid by GEBE to Saba and Statia, a cut to the travel budget of Parliament, the purchase of 3 parcels of land and also maintaining a Nafl. 90 million reserve at all times for the country.

JANUARY 20, 2014

A presentation was given by Mr. J. Romney to the Committee of Justice concerning the Draft Electoral Reconciliation Ordinance as presented by him to Parliament. The intention of the draft law is to remedy the ailments of the current electoral system.

JANUARY 23, 2014

On this day Parliament adopted the following law:

- *Landsverordening, houdende wijziging van de Landsverordening toelating en uitzetting en van de Legesverordening in verband met de afschaffing van de vrijstelling van zegelbelasting, de invoering van leges voor vergunningen tot tijdelijk verblijf of verblijf en enige andere verklaringen (Zittingsjaar 2013-2014-039) (10 votes for and 0 against)*

National Ordinance amending the Ordinance on

Admission and Expulsion and the Stamp Duty ordinance in connection with the abolition of the exemption from stamp tax, the introduction of fees for permits for temporary residence or residence and other declarations

FEBRUARY 11, 2014

On February 11, 2014 the following law was approved by Parliament:

- *Landsverordening houdende wijziging van de Landsverordening inrichting en organisatie landsoverheid tot wijziging van de inbedding en naamgeving van bepaalde organisatieonderdelen andere wetgevingstechnische aanpassingen (Zittingsjaar 2013-2014-034) (unanimously)*

National Ordinance amending the Ordinance structure and organization of Government to amend the embedding and naming of divisions and other legislative technical adjustments

FEBRUARY 12, 2014

On this day the Prime Minister and Minister of General Affairs, the Hon. Sarah A.

Wescot-Williams, gave a presentation to Parliament on the paper “Reforms in Electoral System of Sint Maarten an initiative by the People”. Several Members of Parliament made suggestions to the Prime Minister concerning the removal of the black curtains in the voting booth and the presence of paraphernalia around the voting station.

FEBRUARY 13, 2014

A Central Committee meeting of Parliament was held in which the nomination of a deputy member of the General Audit Chamber of Sint Maarten was discussed. The Sint Maarten Carnival Development Foundation also gave a presentation to Parliament concerning the findings of a market analysis report that was conducted by the organization in that same meeting.

On this same day Mr. mr. R.A. Groenveldt gave a presentation to the Committee of Justice concerning the Small Claims court for Sint Maarten.

FEBRUARY 26, 2014

A Central Committee meeting was held whereby a presentation was given by the Ombudsman, dr. R.J.A. Arduin, concerning the procedure followed by the Ombudsman to present a law to the Constitutional Court,

the decision and ramification thereof for future legislation.

The main goal of the meeting was for the Ombudsman to give an explanation to Parliament on the first verdict of the Constitutional Court of Sint Maarten pronounced on November 8, 2013 where it pertains the Criminal Code as adopted by Parliament on May 25, 2012.

MARCH 7, 2014

Public meeting no. 11, with the following agenda point:

1. *Incoming documents*
2. *Developments at Sint Maarten Princess Juliana International Airport*

was called to be held on this day. Due to a lack of quorum the meeting could not continue on that day but was continued on March 25, May 19 and June 12 in subsequent meetings. The Members of Parliament posed an array of questions concerning the Sint Maarten Princess Juliana International Airport that were answered by the Minister of Tourism, Economic Affairs, Transport and Telecommunication.

MARCH 26, 2014

On this day prof. J. de Boer gave a presentation to

the Committee of Justice concerning the Small Claims court for Sint Maarten.

MARCH 27, 2014

The President of Parliament, the Hon. Gracita R. Arrindell, received a visit from representatives of Transparency International. The purpose of their visit was to introduce themselves to key people in the community prior to commencing their assignment in May.

APRIL 7-9, 2014

The President of Parliament, the Hon. Gracita R. Arrindell, headed a delegation comprising of Member of Parliament the Hon. Roy R. Marlin, Member of Parliament the Hon. Patrick G. Illidge, Member of Parliament the Hon. Frans G. Richardson, Member of Parliament the Hon. Romain J. Laville and Member of Parliament the Hon. Johan E. Leonard, to the Tripartite meeting in Aruba. The delegation also included the Secretary General Jozef D. Semeleer and Advisor Ralph Richardson.





Also present were delegations from Aruba and Curaçao. The following subjects were discussed during this meeting:

- the possibility to establish a joint legislation academy;
- the Unicef report on the situation of children on Aruba, Curaçao and Sint Maarten;
- economic opportunities within the Kingdom;
- Kingdom games.

Two resolutions were adopted by the Tripartite meeting that would have to be ratified as motions by the different Parliaments.

APRIL 11, 2014

On this day Public meeting no. 13 was held with the following agenda points:

1. *Incoming documents*
2. *Establishment of decision lists of Solemn Public meeting no. 1 and 2, decision lists of Public meeting no. 3, 4, 5, 8, 9 and 10*
3. *the decision of the government to purchase Emilio Wilson Estate*

The Minister of Housing,

Spatial Planning, Environment and Infrastructure was present to answer questions on agenda point 3.

APRIL 14, 2014

During the continuation of Public meeting no. 12, the new Rules of Order for the Parliament of Sint Maarten were approved unanimously.

APRIL 16, 2014

On this day the President of Parliament, the Hon. Gracita R. Arrindell, received the final Baseline Study on Institutional Integrity Management Report from the High Council of State, the General Audit Chamber Chairman, Ronald Halman. The baseline study report provides an overview with regards to laws and regulations related to integrity. The General Audit Chamber is authorized to conduct investigations on integrity. The study is a good tool for Members of Parliament to have and utilize to further



strengthen the democratic institutions of the country, especially in the area of integrity, thereby further enhancing parliamentary democracy that the country has today.

APRIL 25, 2014

Parliament adopted the following law on this day:

MAY 8, 2014

Both the advices on the new Ad Hoc Committee New Parliament Building and the President of Parliament Award were approved during this meeting.

With 10 votes cast for, a new Secretary General of Parliament, Ms. Nancy R. Joubert, LL.M., was appointed. The appointment would take effect on May 10, 2014. The



former Secretary General of Parliament, mr. lic. Jozef D. Semeleer, was given a honorable discharge and would function as of May 10, 2014 as the Advisor to the newly appointed Secretary General of Parliament.

A new 1st and 2nd Acting Secretary General of Parliament were also appointed in the same meeting. mr. Van Dyke A. Bell was appointed as the 1st Acting Secretary General of Parliament and Mrs. Ann A. Groen-Gumbs, LL.M. as the 2nd Acting Secretary General of Parliament.

MAY 22-23, 2014

Upon the request of Parlantino back in 2012, the Parliament



of Sint Maarten hosted 3 committee meetings on May 22 and 23, 2014. These committees were:

- *Committee of Energy and Mines;*
- *Committee of Political Affairs, Municipal and Integration;*
- *Committee of Economic Affairs, Social Debt and Regional Development.*

The meetings took place simultaneously at the Sonesta Maho Beach Resort & Casino. Between 50-60 delegates from different Latin American countries visited Sint Maarten to attend these meetings. Topics discussed during these meetings were amongst others the integration and political change in Latin America and the Caribbean, economic financial relations between Latin America and the Caribbean and the Popular Republic of China and the draft framework law on electric energy.

On **MAY 22, 2014** the President of Parliament, the Hon. drs. Gracita R. Arrindell



hosted a welcome reception for the delegates at Sonesta Maho Beach Resort & Casino. His Excellency the Governor, drs. Eugene B. Holiday and the Hon. Prime Minister, Sarah A. Wescot-Williams along with dignitaries from both the French and Dutch side were among the invited guests. The guest speaker was the Acting Secretary General of Parlantino, Mr. Rolando Gonzalez Patricio.



MAY 26, 2014

In Public meeting no. 16, for which the Prime Minister and Minister of General Affairs was invited, the following agenda point were discussed:

1. Proposed merger between TELEM and UTS
2. Amendment of article 36 of the Rules of Order
3. Discussion on the institution of a joint

legislation academy in accordance with the agreement list dated April 9, 2014 of the Tripartite meeting (IS/495/13-14 dated April 11, 2014)

4. Discussion on the Unicef report in accordance with the agreement list dated April 9, 2014 of the Tripartite meeting (IS/495/13-14 dated April 11, 2014)

Agenda point 2 entailed an amendment to remedy an oversight when the new Rules of Order were approved on April 14, 2014. Agenda points 3 and 4 were products of the Tripartite meeting held in Aruba in April 2014. The Tripartite meeting agreed that the resolutions would be presented in the form of motions by the different Parliaments of the countries. The first motion entails the possibility of the institution of a joint legislation academy to train local legislative lawyers and the second one deals with the Unicef report on the situation of children on Aruba, Curaçao and Sint Maarten.

As for agenda point 1, the Prime Minister and Minister of General Affairs answered questions posed by the Members of Parliament concerning the state of affairs on the proposed merger between TELEM and UTS.



JUNE 3-6, 2014

The Interparliamentary Kingdom Consultation (IPKO) was held in the Netherlands during the week of June 3-6, 2014.

After Members of Parliament arrived in the Netherlands, on Tuesday, June 3 a plenary session was held where all delegation leaders gave an opening speech. Also in attendance for this session were the Chairperson of the Second Chamber, Mrs. A. van Miltenburg and Chairperson of the First Chamber, Mrs. A. Broekers-Knol. Thereafter Members of Parliament met to discuss issues of concern.

For three days (Tuesday, Wednesday and Thursday) the Members of Parliament discussed subjects of mutual concern such as youth, education, economic opportunities within the Kingdom, energy, health care, integrity in public

administration within the Kingdom and racism and intolerance.

A decision list was drafted and signed on Friday, June 6 followed by a joint press conference.

The Sint Maarten delegation consisted of President of Parliament, the Hon. drs. Gracita R. Arrindell, Member of Parliament the Hon. Roy R. Marlin, president of the Permanent Parliamentary Committee for Kingdom Affairs and Interparliamentary Relations, Member of Parliament the Hon. William V. Marlin Vice president, Member of Parliament the Hon. Patrick G. Illidge, Member of Parliament the Hon. Frans G. Richardson, and Member of Parliament the Hon. Romain J. Laville, who were all part of the delegation.

The delegation also included Member of Parliament the Hon. Dr. Lloyd Richardson, Secretary General Nancy R. Joubert, LLM and Advisor Ralph Richardson.



JUNE 11, 2014

The Minister of Tourism, Economic Affairs, Transport and Telecommunication gave a presentation to the Committee of Tourism, Economic Affairs, Transport and Telecommunication of Parliament on the Business License Information System (BLIS).

JUNE 12, 2014

On this day, the following law was adopted:

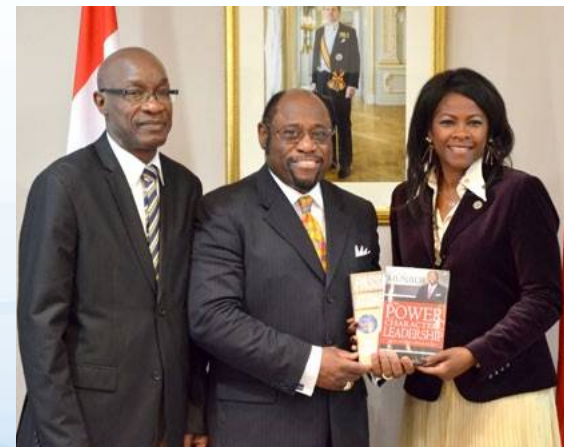
JUNE 18, 2014

The lease agreement for the building in which Parliament is currently housed, will terminate in 2017. In order to explore the possibilities for Parliament to have its own building, the Ad Hoc Committee for the Preparation of the Construction of a New Building for Parliament (Ad Hoc Committee New Parliament Building) was established. The Ad Hoc committee met for the first time on June 18, 2014. During this meeting Member of Parliament the Hon. Dr. Lloyd J. Richardson was appointed as the president and Member of Parliament William V. Marlin as the vice-president of the committee. This first meeting served as a brainstorm session for the Members to express their wishes and concerns where it pertains the new building for Parliament. The committee proposed to have a workgroup established

consisting of experts in the construction field to advise the committee on the matter. Furthermore the committee suggested to add the President of Parliament as a member of the committee.

JUNE 29, 2014

The President of Parliament, the Hon. Gracita R. Arrindell and several other members were honored with a visit from the illustrious faith-based lecturer Dr. Myles Munroe, President and Founder of the Bahamas Faith Ministries International and Myles Munroe International. Dr. Munroe gave the Members of Parliament present insight in his ministry, trainings and work in general.



JUNE 30, 2014

On this date the purchase agreement by and between the heirs for the Frost Family and the public entity, Country Sint Maarten,

represented by the Honorable Minister of Housing, Spatial Planning, Environment and Infrastructure, Mr. Maurice Lake, was on the agenda of Public meeting no. 18. The Minister of Housing, Spatial Planning, Environment and Infrastructure was present and answered questions posed by the Members of Parliament.

AUGUST 8, 2014

Parliament received the Report pursuant to article 23 National Ordinance Ombudsman from the Ombudsman concerning investigation on Kadaster on June 12, 2014. Based on the investigation conducted the Ombudsman concluded that Kadaster fails to understand that as a public entity, executing public tasks, it is bound by the principles of good governance, including propriety, in dealing with the public.

It is the task of Parliament as the highest oversight institution of the land and the representative of the people to ensure compliance with the law by all administrative bodies including the Kadaster, and also restore trust of the citizens in the legal system of Sint Maarten.

For that reason the Minister of Housing, Spatial Planning, Environment and



Infrastructure and the Minister of Finance were invited for Central Committee no. 38 with the agenda point: “*Report pursuant to article 23 National Ordinance Ombudsman concerning investigation on Kadaster (Ref#OM-OBN 0213A/2014) (IS/677/2013-2014 dated June 12, 2014)*” to give a further elucidation on the report.

AUGUST 7, 13, 14, 15, 2014

Members of Parliament followed a training provided by Hanze Legal Consultancy and funded by USONA on the role and functioning of Parliament, the Constitution, the Rules of Order of Parliament, the Kingdom Charter and other topics that are relevant for the work of a Member of Parliament. This training was held in the Conference room of the Parliament building.

AUGUST 18-19, 2014

Sint Maarten hosted a (urgent) Tripartite meeting on August

18-19, 2014. The President of Parliament, the Hon. Gracita R. Arrindell, headed the delegation comprising of Member of Parliament the Hon. Roy R. Marlin, Member of Parliament the Hon. Patrick G. Illidge, Member of Parliament the Hon. Johan E. Leonard and Member of Parliament the Hon. Petrus L. de Weever and Member of Parliament the Hon. Dr. Lloyd J. Richardson. The delegation also included the Secretary



General Nancy R. Joubert, LL.M. and Advisor Ralph Richardson.

Also present were delegations from Aruba and Curacao. The agenda point of the meeting was as follows:

- Position of the delegations of Aruba, Curaçao and Sint Maarten concerning the intervention of the Kingdom government in autonomous matters of our countries without apparently a legal basis and apparent violation of the Kingdom Charter and the Regulation of the Governor.



Maarten to investigate the integrity within the public administration as well as the instruction to the Governor of Aruba to withhold his signature to the draft budget 2014 of that country. The motions adopted by the different Parliaments will also be sent to the Kingdom Government, the Governments of Aruba, Curaçao and Sint Maarten, the First and Second Chamber of the Netherlands and the Kingdom Council of State.

The second resolution intends to emphasize the importance of the introduction as soon as possible of an independent institution that will issue binding rulings in strictly legal disputes where it pertains to the Charter of the Kingdom. While the aforementioned proposal is being worked on, a temporary provision should be created where the Kingdom Government has the obligation to request advice from the Kingdom Council of State where it pertains decisions that already have been taken. Like the first resolution the motions adopted by the different Parliaments will also be sent to the Kingdom Government, the Governments of Aruba, Curaçao and Sint Maarten, the First and Second Chamber of the Netherlands and the Kingdom Council of State.



Two resolutions were adopted by the Tripartite meeting that would have to be ratified as motions by the different Parliaments.

The intention of the first resolution is for the Parliaments of the countries to request their respective governments to put forward a request to the Kingdom Council of State to advise on the actions of the Kingdom Government pertaining to the instruction given to the Governor of Sint

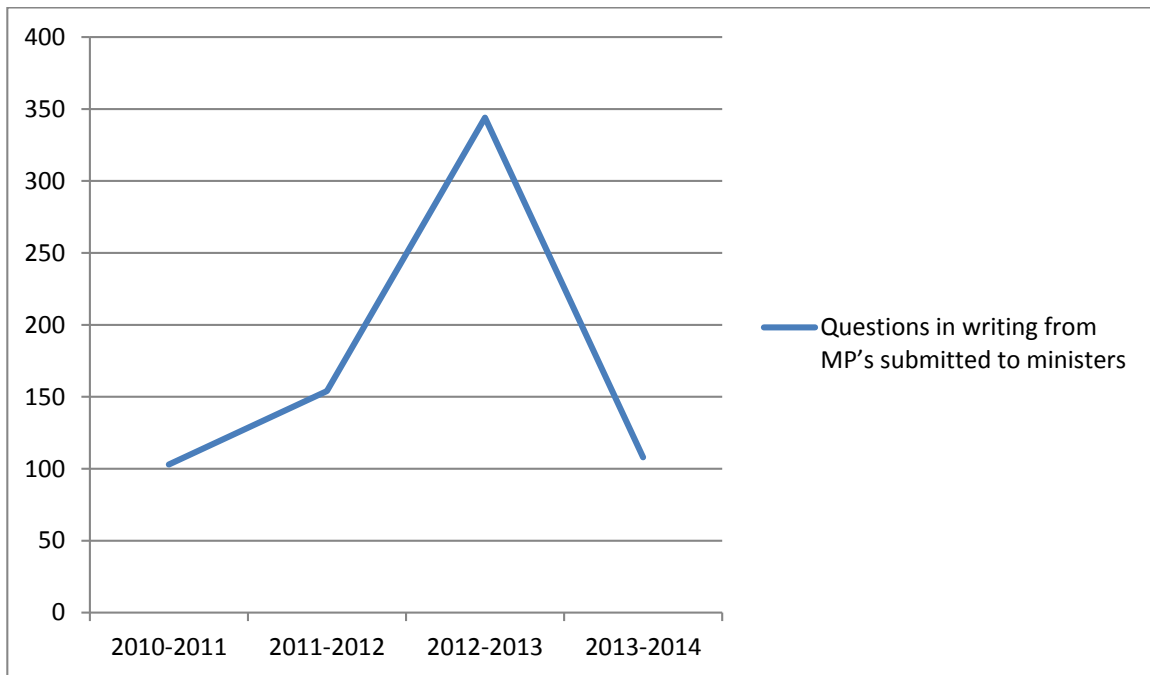

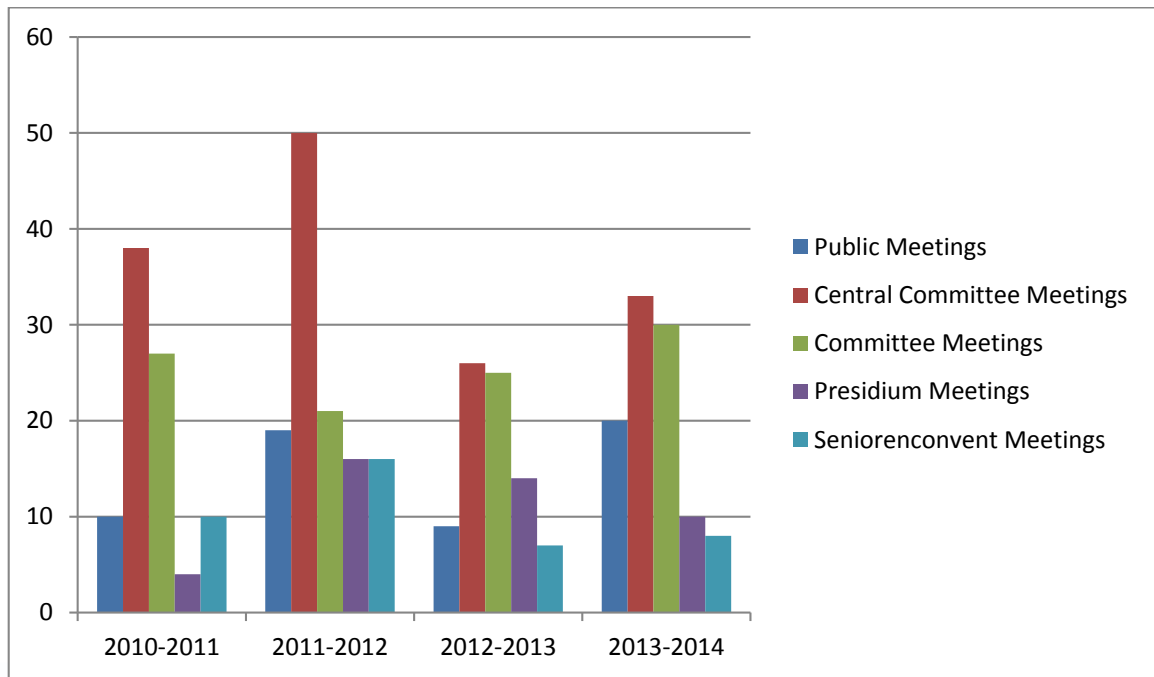
QUESTIONS IN WRITING FROM MP'S SUBMITTED TO MINISTERS DURING THE PERIOD 2010 - 2014

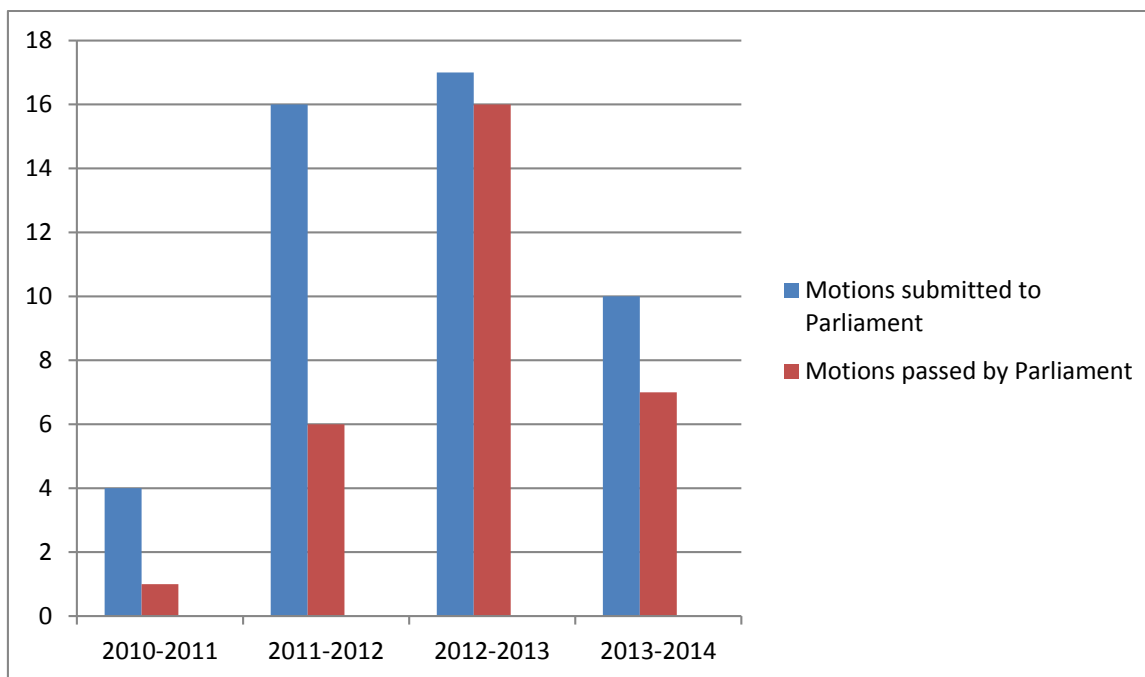

MEETINGS OF PARLIAMENT HELD DURING THE PERIOD 2010 - 2014



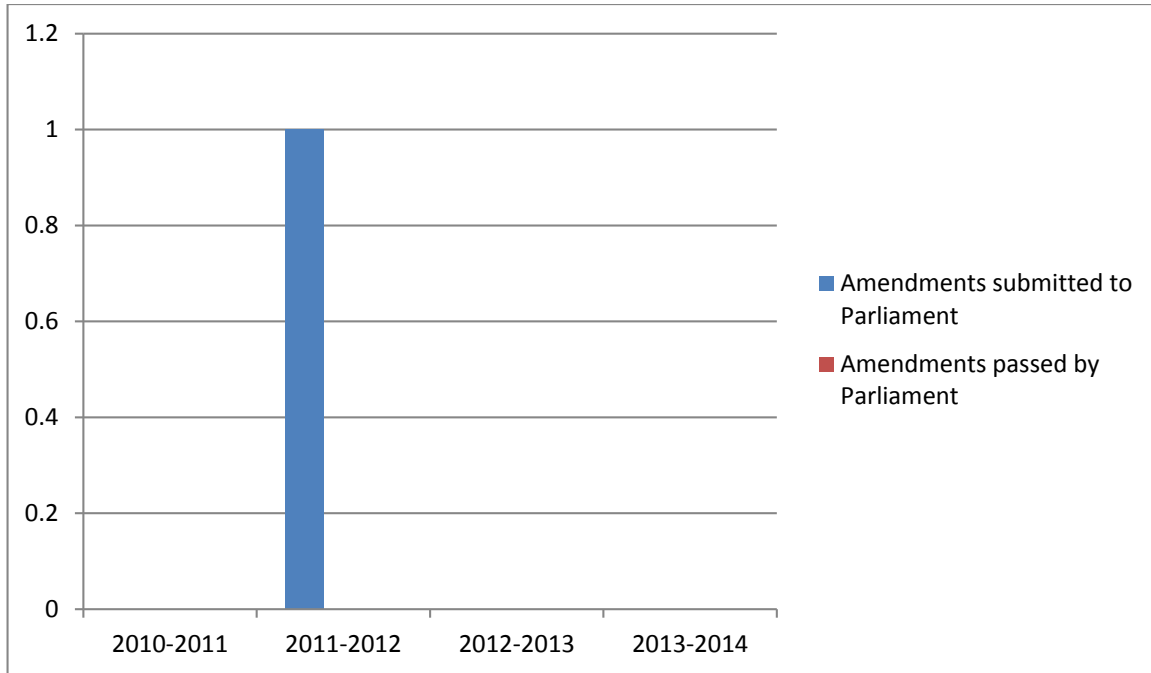

MOTIONS SUBMITTED TO AND PASSED BY PARLIAMENT DURING THE PERIOD 2010 - 2014



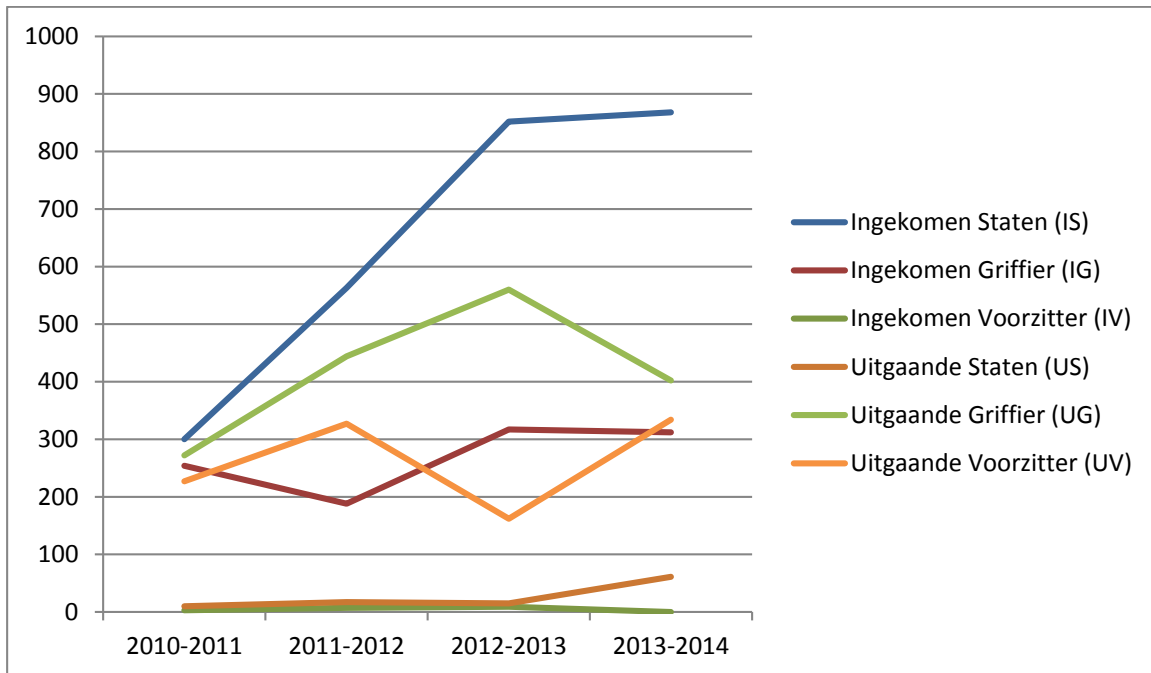

AMENDMENTS SUBMITTED TO AND PASSED BY PARLIAMENT DURING THE PERIOD 2010 - 2014



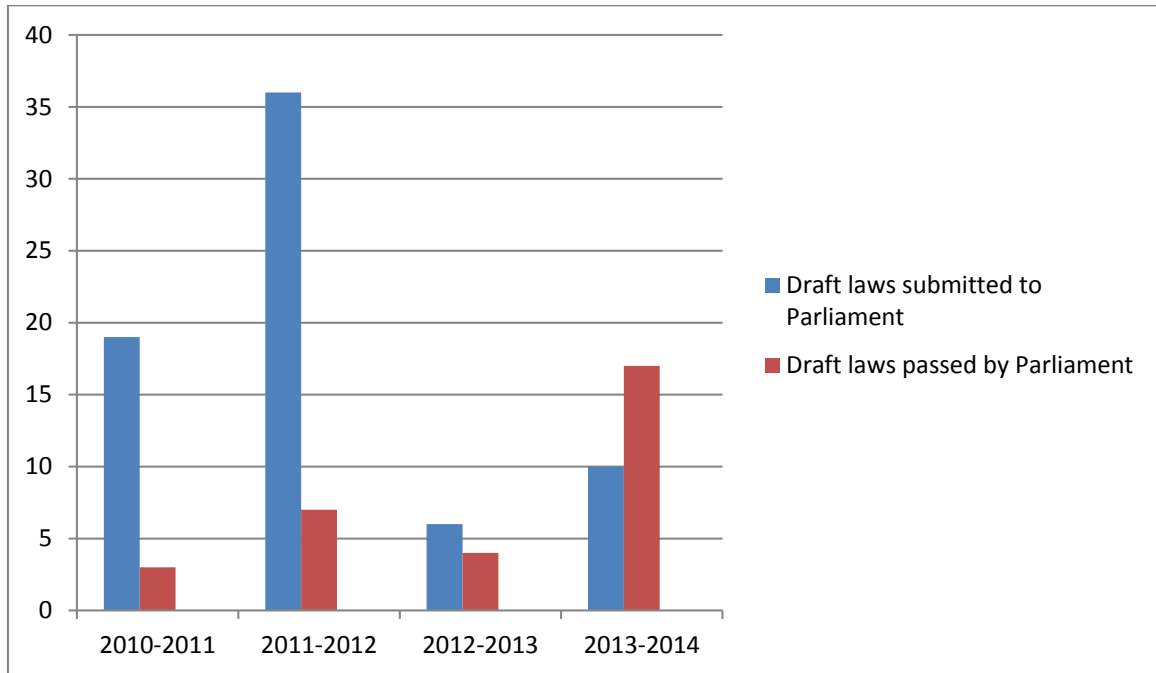

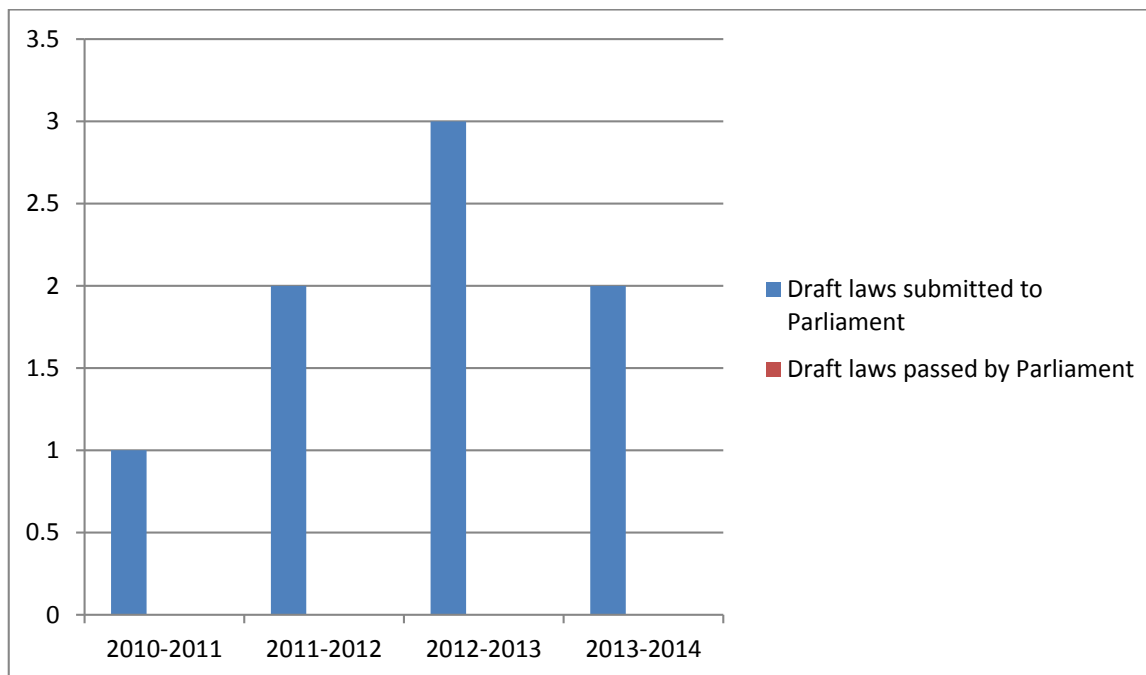
