MOTION

Considering that the coalition majority in Government of St. Maarten which was formed by the NA/DP and independent members of Parliament M. Frans Richardson, Mr. Patrick Illidge and Member of Parliament Mr. Romain Laville, no longer enjoy a majority support;

Considering that a new Governing agreement was arrived at consisting of the UP Faction/Democratic Party and independent Member of Parliament Mr. Romain Laville;

Considering that this governing agreement regulated among others the portfolio responsibility per Ministry for the Political parties and the independent Member of Parliament, the allotment of the functions of Chairperson, and 1st deputy Vice Chairperson of Parliament and the shareholder representative of the Government owned companies.

Considering that in order for a Government to carry out its policies and considerations the remaining Governing period, the Government under normal democratic circumstances, should at all-time be supported by a majority of Members of Parliament and this also includes the person that holds the function of the Chairperson (President) of Parliament.

Considering further that article 57 of the Constitution of St. Maarten states that the Parliament shall elect and appoint from its membership body the Chairperson and Deputy Chairperson of Parliament;

Resolves

To declare that the Chairperson of Parliament Mr. Rudolf Samuel no longer enjoys the support of the majority of Parliament and that Parliament in its meeting of May 24th 2013 dismisses the Chairperson from this function with immediate effect.

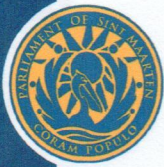
