On August 29th, 2016, you responded in writing to questions raised by me during a meeting of Parliament on June 21st of that same year. The topic was "the financial position of Country Sint Maarten". With respect to the answers provided over 6 months ago, I wish to receive an update on the matters as outlined in my questions and your subsequent answers.

In particular I wish to be apprised of the status a/o progress of:

1. The draft law to forgive taxes prior to 2006. (your letter of August 29th, bullet 1)
2. Amendments to the national accountability ordinance (your letter of August 29th, bullet 2)
3. Integration of the 2 laws relating to the collection of taxes (your letter of August 29th, bullet 3)
4. Loan request to upgrade the Tax Department. (your letter of August 29th, bullet 4)
