Hon. President of Parliament Dr. Lloyd Richardson,

I am writing you with the request to forward the following questions to the Acting Minister of VROMI Hon. Marcel Gumbs and the Minister of Finance, Hon. Martin Hassink as noted in parliamentary house rules of order where it concerns addressing matters to the Council of Ministers.

1. Can the Acting Minister of VROMI provide a current state of affairs with respect to Solid Waste Draft Ordinance?
2. Can the Acting Minister of VROMI provide the current state of affairs with respect to the Cadastre? What is the status of the board? How many members are there? Has the process started to add additional members? Who is part of the Management Team of Kadaster? How is the filing system set up so there is no tampering by third parties. Has the access to files and computer being terminated of the Managing Director, Mr. Roos.
3. Have any steps been taken by the Council of Ministers to consider article 20 section 2 of the 'Landsverordening inrichting en organisatie' to arrange cooperation between the Ministry of Finance and VROMI as a prelude to repairing the 'faulty' ordinance.

As has been brought forward before in the former Council of Minister which I was a member of: Applying article 20 section 2 mentioned, enables government to charge the Ministry of VROMI by Ministerial Decree with the supervision of the tasks assigned to 'Kadaster en Hypotheekwezen', in line with article 19 of afore mentioned ordinance.

Looking forward to a speedy reply.
