*The Parliament of Sint Maarten in its meeting of today, November 2 2017;*

*Considering:*



- *The ongoing negotiations between the St. Maarten and Dutch governments regarding reconstruction aid and conditions attached to this aid,*
- *That the uncertainty due to lack of clarity by the St. Maarten government on these conditions puts the receipt of the funds, slated to be at 100s of millions of euros in serious jeopardy;*
- *That the Parliament of St. Maarten understands the implications of a deadlock between the Netherlands and St. Maarten on the conditions, imposed by the Dutch government. These conditions are an agreed upon integrity chamber ordinance and an agreed upon mutual agreement with respect to border control:*

*Resolves*

- *To express no objection to the draft integrity chamber ordinance WITH the amendments recommended by the Dutch government in its letter to the government of St. Maarten on October 13<sup>th</sup> and presented in draft to the Prime Minister on Tuesday, October 31<sup>st</sup>.*
- *To express no objection to the draft mutual agreement on border control as presented to the minister of Justice on Tuesday, October 31<sup>st</sup>.*
