

- What is the Government doing with respect to the court's verdict regarding suppressing the land fill fires?
- What's the status of the intention, expressed by the Prosecutor's Office to "investigate" the landfill/dump?
- What (extra) cost is been incurred with government's inhouse management of the landfill?

Please provide all and any information that would further enlighten me on the topic of garbage, landfill and waste disposal.
