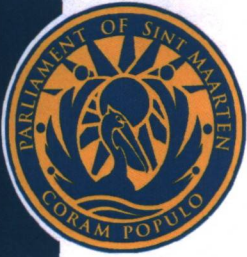

Ref: Questions regarding the status Time Share ordinance

Honorable Minister De Weever,

Recently there was a report of a verdict from the Supreme Court in the daily media where reference was made to the Time Share ordinance of St. Maarten. The issue was that until this day there's no clear indication where the law is and when it will pass.

Some research has shown that the law was passed in parliament in February 2017 and was forwarded to the governor for ratification.

Unfortunately, that didn't happen due to some technical terms that didn't correspond with each other because of the languages in question. (Dutch and English).

Reading the above I have the following questions for you Madame Minister;

1. What is the present status of the law and where exactly is it?
2. Have the necessary changes been made as was indicated by former minister Doncher back in late 2017 to early 2018?
3. Is it the intention of the present government to still finalize the law and send it for ratification once the corrections are made?
4. What timeline are we looking at?
