On December 18th, 2020 a Kingdom Council of Ministers meeting was held in the Second Chamber. The Minister of Plenipotentiary read a statement that supposedly accused the Netherlands for the situation Sint Maarten has found itself in.

The statement of the Minister Plenipotentiary was said to not be well received by the Dutch government and was one of the reasons stipulated as to why the agreement between Sint Maarten and the Netherlands was halted.

To date, only mention has been made of the statements, however the actual statements have not been made available for members of parliament or anyone else for that matter to view.
