Honorable Prime Minister Jacobs,

Season's Greetings to you, family and staff.

There is currently an ongoing debate in Parliament regarding the document(s) signed by your person with regard to the so-called draft COHO Kingdom law.

The debate regards the confidentiality of aforementioned document(s), as allegedly requested by you.

In connection herewith can you please list for me all hereto pertinent documents.

Can you for each document provide the need for its confidentiality.

Has the Country plan (landspakket) for St. Maarten changed from the one made public back in July of this year? If so, what has changed?

Has the draft COHO Kingdom law changed from the one made public in July? If so, what are the changes?

Madam Prime Minister, it is reported that State Secretary Knops will visit St. Maarten in the first week of January 2021, coinciding with the virtual bi-annual IPKO meetings. I consider it highly inconsiderate that other actors are quite aware of the (amended) documents regarding St. Maarten and not the parliament and the people of St. Maarten.

I kindly request you to provide the abovementioned answers as soon as possible.
