Honorable Minister,

I have been informed by several employees of PJIAE that the CEO of PJIAE ordered the security department to provide him with surveillance camera footage of my person having conversations with employees of PJIAE upon my departure from the island on the afternoon of May 19th, 2021.

According to said employees, the CEO of PJIAE considered my conversations with the staff as "illegal" meetings, and said that the employees involved would be fired.

In the first place, I would like to state that as MP, I speak with citizens on a daily basis on different matters. Secondly, if the actions and statements of the CEO are true, this is obviously unacceptable from the perspective of the rights of the employees in question. It would also mean that my privacy as a citizen is being invaded and my integrity as MP is being called into question by the CEO.

I am therefore urgently requesting you to look into this matter and inform Parliament of your documented findings at your earliest convenience.

Depending of your findings, I will consider if any actions, legal or otherwise, are required.
